Purpose

Application

This policy applies to all employees of the Information and Protection of Privacy Commissioner (IPC) and anyone using THE OIPC website.

Policy

Privacy Policy

Our website provides information about our office, The Freedom of Information and Protection of Privacy Act (FOIP), The Local Authority Freedom of Information and Protection of Privacy Act (LA FOIP), and The Health Information Protection Act (HIPA), and other general access to information or privacy issues.

Your internet service provider (ISP) may provide identifiable information such as your Internet Protocol (IP) address to our web server. Further, our web server and your browser will communicate through cookies. These cookies will log your previous activity upon our website so that you will know which links you have already clicked on. Please note we do not use any information provided for any other purpose other than for the operation and maintenance of our website.

Please note we do not collect personal information such as your name, address, or contact information through our website.

Communicating with the IPC

While we accept request for review or investigations by mail, we also accept request for reviews or investigations through email at webmaster@oipc.sk.ca. However, emails may be intercepted so we ask that you exercise caution when determining what information you include in your email to our office. Please note we do not accept request for reviews or investigations through social media.

We will use the personal information you provide to us, such as your contact information, to respond to your inquiry. If you are submitting a request for review or investigation, your personal information may be disclosed to the government institution, local authority, and/or health trustee for the purpose of the review or investigation.

Social Media Policy

The Saskatchewan Information and Privacy Commissioner's office (IPC) uses Twitter, Facebook, and YouTube to communicate with those interested in access and privacy related issues.

Please note the IPC may use information you provide on the IPC's Twitter, Facebook and YouTube accounts – including but not limited to the personal opinions contained in your comments or messages to us – for statistical or analytical purposes.

For YouTube, the IPC cannot identify when you "like" one of our videos, but this information is provided to us by YouTube in aggregate form (i.e. the total number of viewers who "liked" our videos). The IPC may use this information for statistical or analytical purposes and to help us provide content of interest to the public.

Content

The content on the IPC Twitter and Facebook accounts will include the following:

- links to its publications, including reports, blog posts, and resources,
- links to content posted on the Internet related to access and privacy,
- news, tips, facts, and other information about access and privacy.

Posts, retweets or sharing of links to content posted on the Internet is meant for the interest of followers of the IPC Twitter and Facebook accounts. These posts, retweets or sharing of links do not necessarily mean an endorsement of the content by the IPC.

Videos shared on the IPC YouTube Channel include webinars and other video content created by our office on access and privacy matters.

The IPC encourages the use of its social media platforms to discuss matters related to access and privacy. However, in the event the IPC receives offensive, disrespectful or abusive comments, the IPC may block the particular user.

- are contrary to the principles of the Canadian Charter of Rights and Freedoms;

- are aggressive, vulgar, indecent, rude, abusive, coarse, violent, obscene or pornographic in tone or content;

 of any brand, products or services of any company or entity, or any material protected
 by copyright or trademarks;
- are unintelligible or irrelevant to the Page;
- encourage or suggest illegal activity;
- are repetitive or spamming of threads, and
- do not, in the moderators' opinion, add to the normal flow of the discussion.
