## **Why Data Privacy is so Important**

- The shift from paper based society to electronic based society
- The effect Covid has had on electronic communications and record keeping
- Recorded Zoom meetings
- Online visits with Dr's and other health care professionals
- Attended classes online
- Various purchases made online

## **The Result of These Shifts**

- Every one of these activities results in the creation of data. Data that is stored by someone and contains information about you or me.
- Breaches become more frequent, more public and larger in scope containing a large amount of data (e.g. eHealth, SLGA).
- These breaches are occurring not only in our home province, but everywhere.
- The demands of hackers is for ransom and has made hacking more profitable.
- It's not if a breach occurs, but when.
- It is us personally or as employees whose actions cause hackers to get into our systems.

#### What can you do?

- Ensure your organization has constant messaging and warnings about risks
- Never open a suspicious email or non-recognized email
- Never click on a suspicious link or button
- Review our offices presentation on <u>Security and Phishing</u>

## What can Your Organization do?

- Sign up for services that provide education on phishing
- Have someone in your organization send simulated phishing emails to test staff
- Install patches right away
- Review and monitor your firewall
- Have someone within the organization monitor for updates and arrange installation of updates as needed
- Consider additional software applications to protect yourself when working remotely
- Engage a management SOC (security operation center) to monitor your systems 24/7

#### <u>Risks</u>

- The cost of a breach is significant
- Sizable breaches attract media attention
- Reputations are affected
- Trust of those using your service is jeopardized
