Can my local authority publish utility information on its website? (total revenue, number of residential accounts, total kilowatts)

Can my local authority publish utility information on its website?

- Personal information is defined in subsection 23(1) of [LA FOIP](#)
- Personal information must be about an *identifiable individual*
- Personal information includes:
 - information that relates to financial transactions in which the individual has been involved [s. 23(1)(b)]
 - any identifying number such as an account number [s. 23(1)(d)]
 - the home or business address of an individual [s. 23(1)(e)]
 - information that describes an individual's finances, liabilities, net worth, bank balance, financial history or activities or credit worthiness [23(1)(j)]

Can I release it?

- Personal information is defined in subsection 23(1) of [LA FOIP](#)
- Personal information includes:
 - employment history of an individual [s. 23(1)(b)]
 - information that relates to the health history of the individual [s. 23(1)(c)]
- A local authority can choose to withhold personal information of an elected official pursuant to subsection 28(1) of LA FOIP unless there is a reason to disclose under 28(2) or [the Regulations](#)

My local authority has received an access to information request for a report about an adverse event that occurred at one of our parks. It contains personal information. Can I release it?

- **Section 8 of LA FOIP provides:**
 - “Where a record contains information to which an applicant is refused access, the head shall give access to as much of the record as can reasonably be severed without disclosing the information to which the applicant is refused access.”
