REVIEW REPORT 188-2022

Rural Municipality of Rosthern No. 403

July 20, 2023

Summary:

The Rural Municipality of Rosthern No. 403 (RM) received an access to information request under *The Local Authority Freedom of Information and Protection of Privacy Act* (LA FOIP) from the Applicant. The RM released some records and refused to confirm or deny the existence of other records pursuant to subsection 7(4) of LA FOIP. The Applicant asked the Commissioner to conduct a review of the timeliness of the RM's decision, the adequacy of its search for records and its refusal to confirm or deny the existence of additional records. Later, the RM withdrew its claim that subsection 7(4) of LA FOIP applied and it claimed additional discretionary exemptions. Also, during this review, the Commissioner issued a Notice to Produce, and subsequently issued summonses to the RM and its legal counsel to compel production of the records at issue and further information about the claim to subsection 21(a) of LA FOIP. The RM complied with the summonses by providing the Commissioner with the information necessary to determine if it had properly applied subsection 21(a) of LA FOIP. It also elected to make a *prima facie* case that subsection 21(a) of LA FOIP applied to records withheld in full and provided the Commissioner with copies of the records withheld in part. In this Report, the Commissioner refused to consider any discretionary exemptions raised by the RM as it had raised them after it issued its section 7 decision to the Applicant. The Commissioner found that the RM did not comply with sections 7 and 12 of LA FOIP. He also found that the RM did not conduct a reasonable search for records, but had properly claimed that some records were not responsive. The Commissioner found that the RM did not establish a *prima facie* case for the application of subsection 21(a) of LA FOIP for some records. In regards to the records provided to the Commissioner, he found that the RM had properly applied subsections 21(a) and (b) of LA FOIP to some information, but not all. He found that the RM properly applied subsection 28(1) of LA FOIP to one record. The Commissioner recommended that, within 30 days, the RM: 1) release the records for which it claimed new exemptions not previously raised in its section 7 decision or submission; 2) amend its policies or practices for processing access to information requests

to ensure compliance with the timelines set out in LA FOIP; 3) ensure its decisions comply with section 7 of LA FOIP; 4) conduct another search for responsive records and issue a new section 7 decision; 5) consider releasing the non-responsive records, subject to any exemptions that may apply; 6) release a number of records or portions of records, including the headers, footers, subject lines and confidentiality statements that he found were not exempt; and 7) continue to withhold the portions of the records that he found were exempt.

I BACKGROUND

[1] The Applicant made an access to information request under *The Local Authority Freedom of Information and Protection of Privacy Act* (LA FOIP) to the Rural Municipality of Rosthern No. 403 (RM). The RM received the request on July 14, 2022, which was as follows:

Any and all communications (email, recorded audio, texts, notes) between RM council members, staff, non-staff in regards to myself [named, initials], “that guy” or any other designation (code name, code number, etc.) given to myself to identify me. If the above is not clear, please ask.

Any and all communications to and from myself to any and all RM staff, councillors, etc. eg: recorded audio, texts, email etc. to designated councillor phone numbers, emails, text as well as RM of Rosthern office phones etc.

I will limit this request to 2018 to end of 2022.

[2] The Applicant also requested a waiver of the access fees.

[3] In correspondence to the Applicant dated August 9, 2022, the RM extended its time to respond to the request to September 12, 2022, pursuant to section 12 of LA FOIP. The RM also stated that the fees would be waived.

[4] On September 16, 2022, the Applicant filed a request for a review claiming that the RM was deemed to have refused access to the information because it failed to respond to the request. My office opened Review File 183-2022.

[5] By letter dated September 19, 2022 (sent by email on September 22, 2022), the RM issued its section 7 decision to the Applicant. The decision granted access in full to 94 emails

comprised of 204 pages. The RM refused to confirm or deny the existence of other records claiming that section 21 of LA FOIP would apply.

- [6] On September 27, 2022, the Applicant asked my office to conduct a review of the timeliness of the RM's decision, the adequacy of its search for records and its refusal to confirm or deny the existence of records. My office closed Review File 183-2022 because the RM had responded to the access to information request and was no longer in a deemed refusal position. This review file was opened to address the outstanding issues.
- [7] On October 3, 2022, my office notified the Applicant and the RM that my office would be undertaking a review and invited each to provide a submission by December 2, 2022. My office also asked the RM to provide an Index of Records (Index) by November 2, 2022.
- [8] The RM provided my office with an Index on November 10, 2022. The Index listed the records that had been released to the Applicant.
- [9] My office received a submission from the RM on December 2, 2022, and the Applicant on December 5, 2022.
- [10] On December 5, 2022, citing section 9-1 of our office's [*Rules of Procedure, Part 9: Solicitor-Client or Litigation Privilege*](#) (revised December 8, 2022), my office wrote to the RM's legal counsel asking the RM to provide us with copies of the withheld records, if they existed, or an affidavit of records and schedule of records. My office requested this information by December 19, 2022.
- [11] On December 19, 2022, the RM provided my office with an affidavit sworn by the Reeve. However, it did not provide a schedule setting out the records at issue. In response to inquiries from my office, legal counsel for the RM stated on December 20, 2022, that the RM was "not able to provide the records themselves or [a schedule]."

- [12] Following a further exchange of emails between my office and the RM's legal counsel, the RM was asked to provide a schedule in compliance with section 9-1 of the *Rules of Procedure* by January 20, 2023.
- [13] On January 20, 2023, the RM's legal counsel sent an email to my office undertaking to provide a schedule by the end of January 2023. However, it was not until March 20, 2023, that counsel for the RM provided my office with the Schedule of Records (first Schedule).
- [14] On April 3, 2023, my office wrote to legal counsel for the RM with a number of questions about the first Schedule, including whether the RM was continuing to claim that subsection 7(4) of LA FOIP, and general information about the contents of the records and further particulars of how the exemptions in subsections 21(a) and (b) of LA FOIP applied to them. My office requested a response to the questions by April 12, 2023.
- [15] The RM did not respond to this email and on May 15, 2023, my office issued a Notice to Produce Records (Notice) pursuant to section 43 of LA FOIP. The Notice required the RM's Reeve and legal counsel to produce to my office by 10:00 a.m. on May 22, 2023, all documents, information and records responsive to the Applicant's access to information request, including the documents identified in the Affidavit. It also stated that if the Reeve did not comply with this Notice by May 22, 2023, a *subpoena duces tecum* will be issued.
- [16] The RM did not produce the records as required by the Notice. On June 8, 2023, my office issued summonses (*subpoena duces tecum*) to the Reeve and legal counsel pursuant to section 43 of LA FOIP. The summonses required both to appear before me on June 27 and 28, respectively, to be examined under oath and to produce the records identified in the Reeve's Affidavit.
- [17] On June 21, 2023, the RM wrote to the Applicant withdrawing its claim to subsection 7(4) of LA FOIP and it released 12 additional records in full and 20 records in part to the Applicant. One record was released in part and portions withheld pursuant to subsection 28(1) of LA FOIP. It also sent them a second Index and claimed new discretionary exemptions namely, subsections 21(c), 15(1)(b), 16(1)(a), (c) and (d) of LA FOIP for seven

of the records that were withheld in part. The RM withheld portions of one record pursuant to the mandatory exemption in subsection 28(1) of LA FOIP. The second Index included a list of the released and withheld records or portions of records.

[18] The same day the RM provided my office with a copy of the second Index, Supplemental Affidavit, updated Schedule of Records (second Schedule), and responses to the questions raised in my office's email dated April 3, 2023. The RM also advised my office that it was withdrawing its claim to subsection 7(4) of LA FOIP.

[19] The second Schedule listed 56 email records that the RM claimed were not responsive to the request. These non-responsive records were not listed in the second Index sent to the Applicant.

[20] Following correspondence with my office, Records 991 (RMR609), 368 (RMR0512), 369 (RMR0513), and 370 (RMR0514) were released in full to the Applicant. The RM also provided my office with complete copies of the non-responsive records and the records released in part to the Applicant. In response to questions from my office, it also provided copies of some of the records that it claimed were exempt in full pursuant to subsections 21(a) and (b) of LA FOIP.

[21] On June 23, 2023, my office withdrew the summonses.

II RECORDS AT ISSUE

[22] As noted above, the RM initially released 94 emails comprised of 204 pages to the Applicant. During the course of this review, it released an additional 16 emails in full and 20 emails in part to the Applicant.

[23] The Appendix to this Report is a copy of the second Schedule except that my office has redacted any personal information and four columns of information not relevant for the purposes of this review. We have also edited the descriptions of the email records that the RM claims are not responsive to the request.

- [24] It appears that the following records were released in part to the Applicant, but they were shown as having been withheld in full in the RM's second Schedule: 39 (RMR0031), 41 (RMR0036), 310 (RMR0739), 387 (RMR0142), 541 (RMR0822), 581 (RMR0658), 774 (RMR0025) and 768 (RMR0105). The Appendix to this Report sets out all records that appear to have been produced in whole or in part to the Applicant.
- [25] Accordingly, there are 1049 email records at issue in this review that were withheld in full or in part.
- [26] I note that the RM did not raise subsections 21(c), 15(1)(b), 16(1)(a), (c), and (d) of LA FOIP in its section 7 decision to the Applicant or in its submission. It wasn't until it prepared its Supplemental Affidavit, almost one year following receipt of the access to information request, that it claimed these exemptions.
- [27] Section 2-4 to my office's *Rules of Procedure* (effective December 1, 2018, revised December 8, 2022) states that discretionary exemptions, not included in the head's decision under LA FOIP, will not be considered by my office during a review unless there are exceptional circumstances. As the RM raised these exemptions late and has not provided any compelling reasons why I should consider them, I will not be considering them in my review.
- [28] As no other exemptions were claimed in relation to Records 351 (RMR0601), 377 (RMR0521), 378 (RMR0121), 386 (RMR0141), 390 (RMR0145), and 391 (RMR0146), I find that the RM did not properly claim they were exempt. I recommend that, within 30 days of issuance of this Report, the RM release these Records to the Applicant.

III DISCUSSION OF THE ISSUES

1. Do I have jurisdiction?

- [29] The RM is a "local authority" as defined in subsection 2(1)(f)(i) of LA FOIP. Therefore, I have jurisdiction to review this matter.

2. Did the RM comply with section 12 of LA FOIP?

[30] The Applicant claimed that the RM did not respond to their access to information request in accordance with the timelines required by LA FOIP.

[31] As noted above, subsection 7(2) of LA FOIP requires local authorities to issue a decision in response to an access to information request within 30 days.

[32] Subsection 12(1) of LA FOIP gives local authorities the right to extend the time to respond for a reasonable period not exceeding 30 days after the access to information request is received. Subsection 12(2) of LA FOIP requires local authorities to provide notice of the extension within 30 days after receipt of the request. Subsection 12(3) of LA FOIP requires heads to give written notice of its decision in accordance with section 7 of LA FOIP within the period of the extension. These subsections provide:

12(1) The head of a local authority may extend the period set out in section 7 or 11 for a reasonable period not exceeding 30 days:

...

(2) A head who extends a period pursuant to subsection (1) shall give notice of the extension to the applicant within 30 days after the application is made.

(3) Within the period of extension, the head shall give written notice to the applicant in accordance with section 7.

[33] Section 2-28 of *The Legislation Act* prescribes how timelines set out in LA FOIP are calculated. It requires that calendar days are included in the calculation, the first day is excluded from the calculation of time, and if the due date falls on a weekend or a holiday, then the time is extended to the next business day” (*Guide to LA FOIP*, Chapter 3, “Access to Records”, updated: May 5, 2023 [*Guide to LA FOIP*, Ch. 3] at pages 49-50).

[34] The Applicant does not take issue with the RM’s right to extend the time for responding to the request pursuant to subsection 12(1) of LA FOIP or the notice provided pursuant to subsection 12(2) of LA FOIP. Their concern is about the RM’s compliance with the timelines.

[35] The RM provided its notice of extension to the Applicant in correspondence dated August 9, 2022, which was within the 30 days required by subsection 12(2) of LA FOIP and, therefore, the RM complied with that provision. The RM extended the time for responding to the Applicant's access to information request to September 12, 2022. As the RM received the Applicant's request on July 14, 2022, the extension to September 12, 2022 was appropriate.

[36] However, the RM sent its section 7 decision to the Applicant by email on September 22, 2022, which was 10 days following the due date. In its submission, the RM acknowledged that its response was not sent within the deadline. For these reasons, the RM did not comply with subsection 12(3) of LA FOIP. Therefore, I find that the RM did not comply with section 12 of LA FOIP.

[37] I note that the RM's submission asserted that the delay was caused, in part, by legal counsel's work schedule.

[38] My office's [Review Report 001-2023](#), which also involved the RM, recommended that the RM amend its policies or practices for processing access to information requests to ensure that the requests are processed in accordance with the timelines set out in LA FOIP. I will reiterate the same recommendation in here.

[39] I add that while the RM stated in its section 7 decision to the Applicant that it was neither confirming nor denying the existence of records, subsection 7(2)(f) of LA FOIP requires it to specifically cite subsection 7(4) of LA FOIP. In this case, the RM's section 7 decision did not cite subsections 7(2)(f) or 7(4) of LA FOIP. For this reason, I find that the RM did not comply with section 7 of LA FOIP. In the future, I recommend that the RM ensure it complies with section 7 of LA FOIP by quoting the applicable subsections in its decisions.

3. Did the RM conduct a reasonable search for responsive records?

[40] Section 5 of LA FOIP provides an applicant with a right of access to records in the possession or control of a local authority. It states:

5 Subject to this Act and the regulations, every person has a right to and, on an application made in accordance with this Part, shall be permitted access to records that are in the possession or under the control of a local authority.

[41] Subsection 5.1(1) of LA FOIP requires a local authority to respond to an applicant's access to information request openly, accurately and completely. This means that local authorities should make reasonable efforts to not only identify and seek out records responsive to an applicant's access to information request, but to explain the steps in the process. (*Guide to LA FOIP*, Ch. 3, p. 12).

[42] The threshold to be met is one of "reasonableness." In other words, it is not a standard of perfection, but rather what a fair and rational person would expect to be done or consider acceptable.

[43] A reasonable search is one in which an employee, experienced in the subject matter of the records, expends a reasonable effort to locate records which are reasonably related to the request. A reasonable effort is the level of effort you would expect of any fair, sensible person searching areas where records are likely to be stored. What is reasonable depends on the request and related circumstances (*Guide to LA FOIP*, Ch. 3, p. 12).

[44] When an applicant requests a review of the local authority's search efforts, the local authority should provide my office with detailed information about its efforts to conduct a search. The following examples of the type of information that can be provided to my office are relevant here:

- For personal information requests – explain how the individual is involved with the local authority (i.e. client, employee, former employee etc.) and why certain departments/divisions/branches/committees/boards were included in the search.
- Identify the employee(s) involved in the search and explain how the employee(s) is experienced in the subject matter.
- Explain how the records management system is organized (both paper & electronic) in the departments/divisions/branches included in the search.

- Describe how records are classified within the records management system. For example, are the records classified by alphabet, year, function, and subject
- Consider providing a copy of your organization's record schedule and screen shots of the electronic directory (folders & subfolders).
- Explain how a search of mobile electronic devices was conducted (i.e. laptops, smart phones, cell phones, tablets).
- Explain which folders within the records management system were searched and how these folders link back to the subject matter requested. For electronic folders – indicate what key terms were used to search if applicable.
- Indicate the calendar dates each employee searched.
- Indicate how long the search took for each employee.
- Indicate what the results were for each employee's search.
- Consider having the employee that is searching provide an affidavit to support the position that no record exists or to support the details provided. For more on this, see my office's resource, [*Using Affidavits in a Review with the IPC*](#), available on my office's website.

(*Guide to LA FOIP*, Ch. 3, pp. 14-15)

[45] The Applicant claims that a reasonable search for records was not conducted by the RM because its search failed to produce many email records that refer to them by name. The Applicant provided copies of some of these emails to my office. They appear to be excerpts of emails between the Applicant and the RM's legal counsel.

[46] The RM's submission on the search issue asserted:

- The search was carried out primarily by the acting municipal administrator.
- The administrator reviewed the RM's electronic and hard copy correspondence.
- Their electronic searches included email accounts, including administration and elected officials, using the full name and initials of the Applicant, as well as their first and last name, separately.
- As no code name or code number had been assigned to the Applicant the search did not include these items.
- Additional searches were carried out by other municipal staff and elected officials.
- They searched their physical and electronic records, including personal cell phones for any responsive records, including recorded audio, text and emails.

- A separate electronic search was carried out by legal counsel of their record holdings.

[47] The RM has restricted the Applicant from communicating with RM staff and required the Applicant to respond directly to the RM's legal counsel. This means that records responsive to this request could reside within the record holdings managed by the RM's legal counsel.

[48] The RM's submission asserted that legal counsel conducted an electronic search, but it did not include information about the repositories that were searched by legal counsel. Consequently, it is not clear if legal counsel searched paper record holdings, email accounts, and other electronic repositories or devices used by them.

[49] I also note that I have not been provided with any information about the date searches that were conducted, and the length of time spent searching by the RM's staff, elected officials and legal counsel.

[50] The information provided in this case about the search is not sufficient to support a finding of reasonable search. For these reasons, I find that the RM did not conduct a reasonable search for responsive records.

[51] I recommend that, within 30 days of issuance of this Report, the RM conduct another search for all records requested by the Applicant and issue a new section 7 decision, with a copy to my office, that includes details of its search efforts and its decision on any additional responsive records found during the search.

4. Did the RM properly withhold information as non-responsive to the Applicant's request?

[52] The RM's Supplementary Affidavit claimed that 56 email records are not responsive to the Applicant's access to information request. It provided copies of these records to my office following the issuance of the summonses to the RM and its legal counsel. Subsequently, the RM dropped its claim that Record 508 (RMR0742) was exempt pursuant to subsections

21(a) and (b) of LA FOIP, claimed that it was not responsive and provided a copy to my office. Consequently, the RM claimed that there are 57 non-responsive records.

[53] When a local authority receives an access to information request, it must determine what information is responsive to the request. Responsive means relevant and refers to anything that is reasonably related to the request. It follows that any information or records that do not reasonably relate to an applicant's request will be considered "not-responsive."

[54] The purpose of LA FOIP is best served when a local authority adopts a liberal interpretation of a request. If it is just as easy to release the information as it is to claim not responsive, the information should be released (i.e., releasing the information will not involve time consuming consultations nor considerable time weighing discretionary exemptions). If a local authority has any doubts about the scope of a request, it has a duty to assist an applicant in clarifying or reformulating the request (*Guide to LA FOIP*, Ch. 3, at p. 27)

[55] Initially the RM did not withhold any information as not responsive but instead claimed that all of the records are exempt pursuant to subsections 21(a) and/or (b) of LA FOIP. However, in its Supplemental Affidavit, the Reeve attested that the records subsequently identified as non-responsive were:

Related to legal matters involving the applicant, but which did not refer to [them] by name or by other identifier;

Were administrative matters related to the applicant (for instance, delivery of electronic meeting invitations to facilitate [their] attendance on Council meetings), but which did not name [them] personally; or

Simply misfiled (such as the email inquiries from the [newspaper] and follow up from [organization]).

[56] The Applicant's access to information request is for "any and all communications (email, recorded audio, texts, notes) between RM council members, staff, non-staff in regards to myself ..." Applying a liberal interpretation, it is broader than a request for access to records that "refer to the [applicant] by name or by other identifier." Therefore, the RM should have treated any records that are "in regards to" the Applicant, or about or pertaining

to the Applicant, as responsive to the request. This is the same approach taken by me in my office's [Review Report 229-2017, 031-2017 – Part II](#) which also involved the RM.

[57] As noted above, copies of all of the non-responsive records were provided to my office. Some of the records are email chains involving the RM's Administrator, RM's legal counsel and third parties. In some cases, the emails appear to be about matters that the Applicant may have been involved in, but they do not relate to them even on the broadest interpretation of that phrase. Other emails are not about matters that the Applicant was involved in. For these reasons, and even on a liberal interpretation of the access to information request, I find the RM properly concluded that the email records are not responsive to the request.

[58] Despite my finding that these records are not responsive, consistent with my blog, "[What About the Non-Responsive Records?](#)" and my office's [Review Report 173-2020, 190-2020 and 157-2021](#), the RM should consider releasing the non-responsive records, subject to any exemptions that may apply. For example, some of the records withheld as not responsive appear to contain information that may qualify as personal information pursuant to subsection 28(1) of LA FOIP, which is a mandatory exemption. I recommend that within 30 days of issuance of this Report, the RM consider releasing the non-responsive records referred to in the Appendix, subject to any exemptions that may apply.

5. Did the RM establish a *prima facie* case that subsection 21(a) of LA FOIP applies to the records withheld in full?

[59] The RM applied subsection 21(a) of LA FOIP to the email records withheld in full and to portions of other email records. My office's *Rules of Procedure*, at page 34, outlines the process a local authority must follow when claiming solicitor-client or litigation privilege:

9-1 Claiming solicitor-client or litigation privilege

(1) Where solicitor-client or litigation privilege is being claimed as an exemption by the head or delegate, the commissioner's office will request the head or delegate to provide a copy of the records, or an affidavit of records, schedule and redacted record

over which solicitor-client or litigation privilege is claimed setting out the elements requested in Form B.

[60] As noted above, following issuance of the summonses, the RM elected to make a *prima facie* case that subsection 21(a) of LA FOIP applied to all the records withheld in full. For those records where it claimed that subsection 21(a) of LA FOIP applied to portions of a record, the RM provided my office with copies of the records. I will address the application of this subsection to those records later on in this Report.

[61] To support its claim that a *prima facie* case was made, the RM provided my office with an Affidavit, first Schedule and a submission. Subsequently, it provided a Supplemental Affidavit, second Schedule, and further information about the records.

[62] Subsection 21(a) of LA FOIP provides:

21 A head may refuse to give access to a record that:

(a) contains any information that is subject to any privilege that is available at law, including solicitor-client privilege;

[63] This is a discretionary exemption. It permits refusal of access in situations where a record contains information that is subject to any legal privilege, including solicitor-client privilege (*Guide to LA FOIP*, Chapter 4: “Exemptions from the Right of Access”, Updated: April 29, 2021, [*Guide to LA FOIP*, Ch. 4], p. 219).

[64] The purpose of solicitor-client privilege is to assure clients of confidentiality and enable them to speak honestly and candidly with their legal representatives. My office applies the following three-part test in determining if this exemption was properly applied:

1. Is the record a communication between a solicitor and client?
2. Does the communication entail the seeking or giving of legal advice?
3. Did the parties intend for the communication to be treated confidentially?

(*Guide to LA FOIP*, Ch. 4, pp. 221-225)

[65] The RM has also claimed that Records 551 (RMR0833.001) and 583 (RMR0660.001) are subject to litigation privilege. Litigation privilege exempts documents, which come into existence after litigation commenced or in contemplation of litigation, and where they have been made with a view to such litigation. The purpose of litigation privilege is to create a “zone of privacy” in relation to pending or apprehended litigation. To achieve its purpose, parties to litigation, represented or not, must be left to prepare their contending positions in private, without adversarial interference and without fear of premature disclosure (*Guide to LA FOIP*, Ch. 4, p. 232).

[66] My office applies the following two-part test where litigation privilege is claimed:

1. Has the record or information been prepared for the dominant purpose of litigation?
2. Is the litigation ongoing or anticipated?

(*Guide to LA FOIP*, Ch. 4, pp. 233-234)

[67] As all of the records at issue are email records, I will first consider if subsection 21(a) of LA FOIP applies to the headers, footers, subject lines and confidentiality statements in the emails.

[68] Section 8 of LA FOIP is relevant here. It provides:

8 Where a record contains information to which an applicant is refused access, the head shall give access to as much of the record as can reasonably be severed without disclosing the information to which the applicant is refused access.

[69] I am not satisfied that the headers, footers, subject lines and confidentiality statements in the emails at issue would contain communications (or the substance of any communications) where legal advice was sought or given. I also note that this type of information was already shared with the Applicant when the RM provided them with the second Index which included information about the date, sender, recipient and subject line of the responsive emails. Therefore, I find that the RM has not made a *prima facie* case that subsection 21(a) of LA FOIP applies to these portions of the emails. I will consider below if these portions of the emails are exempt pursuant to subsection 21(b) of LA FOIP.

Solicitor-client privilege

[70] I now turn to consider whether the three-part test for the application of solicitor-client privilege in subsection 21(a) of LA FOIP is met in relation to records where the RM is making a *prima facie* case that the exemption applies to the entire record.

1. Is the record a communication between a solicitor and client?

[71] A “communication” is the process of bringing an idea to another’s perception; the message or ideas so expressed or exchanged; the interchange of messages or ideas by speech, writing, gestures or conduct (*Guide to LA FOIP*, Ch. 4, p. 221).

[72] A “client” means a person who consults a lawyer and on whose behalf the lawyer renders or agrees to render legal services; or having consulted the lawyer, reasonably concludes that the lawyer has agreed to render legal services on their behalf. It includes a client of the law firm in which the lawyer is a partner or associate, whether the lawyer handles the client’s work (*Guide to LA FOIP*, Ch. 4, p. 222).

[73] A “lawyer” means a member of the Law Society and includes a law student registered in the Society’s pre-call program (*Guide to LA FOIP*, Ch. 4, p. 222).

[74] The local authority should make it clear who the solicitor is and who the client is.

[75] In the second Schedule, the Reeve identified the sender and receiver of each email in the email chain. In the Supplemental Affidavit, they set out the roles of the senders and receivers.

[76] With some exceptions discussed below, based on the information provided to my office, I am satisfied that the RM’s legal counsel and other legal counsel in their firm, Robertson Stromberg LLP, were parties to the communications with the RM and the RM was the client. Therefore, I find, with the exceptions described below, the records at issue are communications between a solicitor and client.

- [77] Record 1 (RMR0315) is an email between the RM and legal counsel's assistant. It appears to have been sent on behalf of legal counsel and therefore, I find that part one of the test has been met for this email.
- [78] The following emails are communications between the RM administrator and others within the RM, and not legal counsel: Records 200 (RMR0425), 364 (RMR0487), and 187 (RMR0854). Therefore, these records do not meet part one of the test.
- [79] The RM's second Schedule did not provide any information about the sender and the recipient of Record 925 (RMR0757). Therefore, I find that this record does not meet part one of the test.
- [80] Finally, Records 551 (RMR0833) and 583 (RMR0660) are emails between the RM and a third party, who is not legal counsel, and therefore, they do not meet part one of the test for solicitor-client privilege. I will address the claim that they are subject to litigation privilege below.
- [81] As all three parts of the test for the application of subsection 21(a) of LA FOIP must be met for the exemption to apply, there is no need for me to consider if parts two and three have been met for these records. Accordingly, I find that the RM has not made a *prima facie* case that subsection 21(a) of LA FOIP applies to Records 200 (RMR0425), 364 (RMR0487), 187 (RMR0854), and 925 (RMR0757). As the RM claimed that subsection 21(b) of LA FOIP applies in the alternative, I will consider if these records are exempt pursuant to that exemption below.

2. Does the communication entail the seeking or giving of legal advice?

- [82] "Legal advice" means a legal opinion about a legal issue and a recommended course of action, based on legal considerations, regarding a matter with legal implications (*Guide to LA FOIP*, Ch. 4, p. 224).

[83] The RM's Affidavit and Supplemental Affidavit assert that the communications at issue relate to communications for the purposes of seeking or obtaining legal advice.

[84] The Applicant's submission touched on this part of the test. They stated:

The RM of Rosthern's lawyer [name withheld] sent me a letter in January 2021 stating that the RM of Rosthern wanted all communication to be sent through her ([name of law firm] email address) any and all communications relating to the RM of Rosthern. At the time I expressed concern to [name withheld] and the RM of Rosthern that a scenario could arise that I would request personal information and that the RM would deny that request based on Lawyer/client privilege. The RM of Rosthern and [name withheld] ignored my concerns.

If the RM of Rosthern and [name withheld] are allowed to withhold the many many emails and communications intended for the RM of Rosthern that were communicated simply because the RM itself asked me to send all communications through their legal representation, a very dangerous precedent would be set. If that action is allowed to take place, any and all public bodies could simply CC (carbon copy) their lawyer's email address and then claim lawyer/client privilege for any and all communications. This is precisely what has occurred over the last two years. I have attached a few email examples to show that there are many emails that were not provided in this LA FOIP request that exist. This does not represent all of the emails that exist and none of the many many emails discussing myself amongst the RM counsellors [sic] and RM staff.

[85] As noted above in the discussion on reasonable search, the RM's submission asserted that due to circumstances between the Applicant and the RM, communications between the Applicant "flow through" legal counsel's office. On the application of subsection 21(a) of LA FOIP, it asserted:

As indicated above, the section 21 exemption is applied by the RM in relation to communications between the RM and its legal counsel. Given the volume of records, it is simply not possible to identify each of them. However, the RM advises that its communications with legal counsel which would be responsive to the request are exclusively for the purposes of seeking and receiving legal advice. Accordingly, these communications are categorically protected by ss. 21(a) and (b).

[86] Given the Applicant's concerns and the RM legal counsel's involvement in the communications with them, my office asked the RM's legal counsel to describe their role in access to information matters involving the Applicant. We also asked them to provide my office with copies of records that would illustrate their role in processing access to

information requests and other correspondence involving the Applicant. In response, the RM's legal counsel provided some of the emails at issue and asserted:

[The emails provided] reflect how an information request (or in this case, follow up to a review response) would be handled – the RM administrator carries out the search, and [...] would send the results of the search for legal comment review. My email to the administrator is the provision of advice on which documents would be solicitor-client privileged, personal information redactions, etc.

[87] It appears from a review of the emails that while legal counsel may receive correspondence from the Applicant, the work necessary to develop responses and process access to information requests is carried out by the RM. A review of the email records also confirms that legal counsel was involved in providing legal advice on such matters as the appropriate application of exemptions, the content of the section 7 decision letters, the adequacy of the searches carried out by RM staff, and compliance with the duty to assist.

[88] Having carefully considered the information provided, not including headers, footers, subject lines and confidentiality statements as discussed above, I am satisfied that part two of the test has been met. I now turn to consider part three of the test.

3. Did the parties intend for the communication to be treated confidentially?

[89] For the third part of the test, I must determine if there is an expectation on the part of the RM that the communication will be confidential. Without confidentiality there can be no privilege and when confidentiality ends so too should the privilege. As a general rule, the client (usually a local authority) must not have disclosed the legal advice (either verbally or in writing) to parties who are outside of the solicitor-client relationship (*Guide to LA FOIP*, Ch 4, pp. 225-226).

[90] In its Supplemental Affidavit, the RM attested that the records were intended to be kept confidential and have been consistently treated as confidential.

[91] Given the nature of the records and the information provided by the RM, with some exceptions discussed below, it appears that the parties intended the communications to be

treated confidentially. Therefore, subject to the discussion that follows, the third part of the test is met.

[92] The RM claimed that subsection 21(a) of LA FOIP applies to two records that involve communications between the RM, legal counsel and third parties. Record 664 (RMR0164) is an email between legal counsel, the RM and my office. Record 588 (RMR0665) is an email between legal counsel, the Ombudsman's office and the RM. To support the claim that there was an intention to treat the information as confidential, I have the Supplemental Affidavit of the Reeve.

[93] Where a client authorizes its solicitor to reveal a solicitor-client communication, either it was never made with the intention of confidentiality, or the client has waived the right to confidentiality. In either case, there is no intention of confidentiality and no privilege attaches. For example, it has been held that documents prepared with the intention that they would be communicated to a third party, or where on their face they are addressed to a third party, are not privileged (*Guide to LA FOIP*, Ch. 4, pp. 228-229).

[94] Waiver of privilege means the voluntary relinquishing of a right, exemption, or immunity. Solicitor-client privilege belongs to the client and persists unless it is waived by the client. To constitute a valid waiver, two essential prerequisites are generally necessary:

- i) the client knows of the existence of the privilege; and
- ii) the client demonstrates a clear intention to forego the privilege.

(*Guide to LA FOIP*, Ch. 4, p. 229)

[95] Waiver of privilege can be express, inadvertent, by implication or where fairness requires. There must be an intention manifested from either the client's voluntary disclosure of confidential information or from objective consideration of the client's conduct (*Guide to LA FOIP*, Ch. 4, p. 229).

[96] Given the description of the emails provided by the RM, even if they contained legal advice, it appears that there was no intention that the information in them was to be treated

confidentially or the RM has waived the right to confidentiality by sharing the information with third parties. Therefore, I find that the RM has not met the third part of the test for these two records.

[97] The RM's Supplemental Affidavit stated that in the case of emails involving third parties, the parties had "sufficient common interest in the same transactions." This raises the question of whether the solicitor-client privilege has been preserved (or not waived).

[98] My office applies the following test to determine if common interest privilege applies:

1. Does the record contain information that is subject to any privilege that is available at law?
2. Do the parties who share the information have a "common interest", but not necessarily an identical interest, in the information?

(Guide to LA FOIP, Ch. 4, p. 230)

[99] Other than the bald assertion that the third parties have a common interest in the subject matter of the emails at issue, I have no information about the context for these emails and the contents. I also note that similar emails involving the same third parties were released in part to the Applicant, but there is no indication as to why Records 664 (RMR0164) and 588 (RMR0665) should be treated differently. I am not persuaded that the RM has made a *prima facie* case for these records. I will consider below whether they are subject to the exemption in subsection 21(b) of LA FOIP.

Litigation privilege

[100] As noted above, the RM also claimed that Records 551 (RMR0833) and 583 (RMR0660) were exempt pursuant to subsection 21(a) of LA FOIP because they were subject to litigation privilege.

[101] The RM asserted that the emails contain a threat of legal proceedings and therefore, would be protected by this exemption. It added that the individual involved in the emails had threatened to take legal action for having been ejected from a council meeting.

[102] I note that the emails in question are dated in May and June of 2020. The RM did not provide any information to suggest that litigation was ongoing or was anticipated at the present time. Accordingly, I find that the second part of the test for litigation privilege has not been met. As the RM must establish that both parts of the test for the application of litigation privilege have been met, I am not persuaded that the RM has made a *prima facie* case for these records. I will consider below whether they are subject to the exemption in subsection 21(b) of LA FOIP.

6. Did the RM properly apply subsection 21(a) of LA FOIP to the records withheld in part?

[103] The RM applied subsection 21(a) of LA FOIP to portions of the following records: Records 39 (RMR0031), 41 (RMR0036), 310 (RMR0739), 387 (RMR0142), 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), 540 (RMR0821), 541 (RMR0822), 551 (RMR0833), 581 (RMR0658), 774 (RMR0025), 768 (RMR0105), and 915 (RMR0039). As the RM is not claiming that it has made a *prima facie* case for these records and I have copies of them, I must now determine if the RM has met the test for the application of this exemption.

[104] Records 39 (RMR0031) and 915 (RMR0039) are emails without any text other than the header, footer and confidentiality statement. They are from the RM to legal counsel, and appear to have been sent to forward another email. I find that the withheld portions do not contain legal advice and therefore, part two of the test has not been met. As all three parts of the test must be met, I find that the RM did not properly apply subsection 21(a) of LA FOIP to these records. Below, I will consider if the information is exempt pursuant to subsection 21(b) of LA FOIP.

[105] The withheld portions of Records 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), and 774 (RMR0025) are emails from the RM to legal counsel. In the case of Record 539

(RMR0820), emails from legal counsel to the RM were also withheld. With one exception, the RM is not seeking legal advice and the withheld information does not contain any legal advice. Therefore, with one exception, I find that part two of the test for subsection 21(a) of LA FOIP has not been met for these records and that the RM did not properly apply the exemption. I will consider below the claim that subsection 21(b) of LA FOIP applies to these records.

[106] Record 539 (RMR0820), page 2, the third and fourth sentences of the email dated May 4, 2020 9:56 am appear to contain legal advice provided by counsel for the RM to the Administrator. However, I note that the same email was released to the Applicant in Record 537 (RMR0818). Given that the email was released, I find that subsection 21(a) of LA FOIP cannot be applied. I recommend that the RM release the withheld portions of Record 539 (RMR0820) to the Applicant.

[107] The withheld portions of Records 41 (RMR0036), 310 (RMR0739), 387 (RMR0142), 541 (RMR0822), 581 (RMR0658) and 768 (RMR0105), include emails from legal counsel to the RM or from the RM to legal counsel that either contain legal advice or seek legal advice and it appears that they were intended to be treated confidentially. Therefore, I find that the RM properly applied subsection 21(a) of LA FOIP to these records.

[108] The withheld portions of Record 540 (RMR0821) include an email from the RM's administrator to the Applicant sent on May 4, 2020 at 10:07:01 am and the Applicant's response sent on May 4, 2020 at 11:54 am. These emails do not contain legal advice or information seeking legal advice and therefore do not meet the test for the application of subsection 21(a) of LA FOIP. The other emails in this record are between the RM and legal counsel, they contain legal advice, and it appears that they were intended to be treated confidentially. I find that the RM did not properly apply subsection 21(a) of LA FOIP to this record.

[109] My findings made above regarding the headers, footers, subject lines and confidentiality statements in the emails withheld in full apply equally to the emails withheld in part. This type of information is not exempt pursuant to subsection 21(a) of LA FOIP, it can be easily

severed from the exempt information in the email and it should be released to the Applicant, subject to my consideration of the potential application of subsection 21(b) of LA FOIP.

[110] I will next consider the RM's claim that subsection 21(b) of LA FOIP applies to the information I have found is not exempt pursuant to subsection 21(a) of LA FOIP.

7. Did the RM properly apply subsection 21(b) of LA FOIP to other records?

[111] I now turn to consider if the RM properly applied subsection 21(b) of LA FOIP to the information that I have found is not exempt pursuant to subsection 21(a) of LA FOIP, including the headers, footers, subject lines and confidentiality statements in the email records.

[112] Subsection 21(b) of LA FOIP is a discretionary exemption. It provides:

21 A head may refuse to give access to a record that:

...

(b) was prepared by or for legal counsel for the local authority in relation to a matter involving the provision of advice or other services by legal counsel; or

[113] The two-part test for subsection 21(b) of LA FOIP, which can be found in the *Guide to LA FOIP* at page 237, is as follows:

1. Were the records "prepared by or for" an agent or legal counsel for a local authority?
2. Were the records prepared in relation to a matter involving the provision of advice or other services by the agent or legal counsel?

[114] First, I will consider the records where I found the RM did not make a *prima facie* case that subsection 21(a) of LA FOIP applies. Then, I will consider the records for which the RM elected to provide my office with copies wherein I found that the RM did not properly apply subsection 21(a) of LA FOIP.

- [115] I have not been provided with copies of Records 200 (RMR0425), 364 (RMR0487), 187 (RMR0854), 551 (RMR0833), 583 (RMR0660), 588 (RMR0665), 664 (RMR0164) and 925 (RMR0757). Given the limited information provided about the contents of the records and in the absence of a copy of the records, I cannot find that the exemption was properly applied.
- [116] Accordingly, I find that the RM has not met its burden of proof regarding its claim that subsection 21(b) of LA FOIP applies. Therefore, I find the RM did not properly apply subsection 21(b) of LA FOIP to Records 200 (RMR0425), 364 (RMR0487), 187 (RMR0854), 551 (RMR0833), 583 (RMR0660), 588 (RMR0665), 664 (RMR0164) and 925 (RMR0757). As no other exemptions have been claimed for these records, I recommend that they be released to the Applicant subject to any mandatory exemptions that may apply.
- [117] I now turn to consider the information withheld from Records 39 (RMR0031), 43 (RMR0039), 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), 540 (RMR0821), 774 (RMR0025), and 915 (RMR0039) that I have found is not exempt pursuant to subsection 21(a) of LA FOIP.
- [118] The withheld portions of Records 39 (RMR0031), 43 (RMR0039), 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), 774 (RMR0025), and 915 (RMR0039) contain information that was prepared by or for legal counsel in relation to a matter involving the provision of advice or other services by the agent or legal counsel. Therefore, both parts of the test for the application of subsection 21(b) of LA FOIP have been met and I find that the RM properly applied subsection 21(b) of LA FOIP to these records.
- [119] I also find that Record 540 (RMR0821) contains information provided by and for legal counsel by the RM for the provision of services by legal counsel and that the RM properly applied subsection 21(b) of LA FOIP to this record. There is one exception, the email from the Applicant to the RM that was withheld on page 2 of the Record is not exempt. I recommend that it be released to the Applicant as no other exemptions have been claimed for that portion of the record.

[120] The headers, footers, subject lines and confidentiality statements in the emails do not qualify for exemption pursuant to subsection 21(b) of LA FOIP as they do not contain information provided by and for legal counsel by the RM for the provision of services by legal counsel. As this information can be reasonably severed from the exempt portions of all emails, I recommend that, within 30 days, the RM sever the exempt information and release the headers, footers, subject lines and confidentiality statements to the Applicant as is their obligation under section 8 of LA FOIP.

8. Did the RM properly apply subsection 28(1) of LA FOIP?

[121] The RM applied subsection 28(1) of LA FOIP to the name and file number associated with an individual from Record 526 (RMR0082). Subsection 28(1) of LA FOIP is a mandatory exemption that protects the privacy of individuals whose personal information may be contained within records responsive to an access to information request made by someone else. It prohibits the disclosure of personal information unless the individual about whom the information pertains consents to its disclosure or the disclosure without consent is authorized by subsection 28(2) or section 29 of LA FOIP (*Guide to LA FOIP*, Chapter 6, “Protection of Privacy”, updated February 27, 2023 [*Guide to FOIP*, Ch. 6], p. 163). Section 28(1) of LA FOIP provides:

28(1) No local authority shall disclose personal information in its possession or under its control without the consent, given in the prescribed manner, of the individual to whom the information relates except in accordance with this section or section 29.

[122] Subsection 23(1) provides a list of examples of personal information. However, to qualify as personal information, the information must be about an identifiable individual and must be personal in nature. Subsection 23(1)(k) of LA FOIP is relevant here. It states:

23(1) Subject to subsections (1.1) and (2), “personal information” means personal information about an identifiable individual that is recorded in any form, and includes:

...

(k) the name of the individual where: (i) it appears with other personal information that relates to the individual; or (ii) the disclosure of the name itself would reveal personal information about the individual.

[123] I find that given the context of the information, the individual's name and corresponding file number qualify as the individual's personal information pursuant to subsection 23(1) of LA FOIP. There is no suggestion that the individual consented to the release of this information. For this reason, I find that the RM properly applied subsection 28(1) of LA FOIP to the withheld information.

IV FINDINGS

[124] I find that I have jurisdiction to conduct this review.

[125] I find that the RM did not properly claim that Records 351 (RMR0601), 377 (RMR0521), 378 (RMR0121), 386 (RMR0141), 390 (RMR0145), and 391 (RMR0146) were exempt.

[126] I find that the RM did not comply with section 12 of LA FOIP.

[127] I find that the RM did not comply with section 7 of LA FOIP.

[128] I find that the RM did not conduct a reasonable search for records.

[129] I find that the RM did not establish that a *prima facie* case that subsection 21(a) of LA FOIP applies to the headers, footers, subject lines and confidentiality statements in the records that were withheld in full.

[130] I find that the RM did not establish a *prima facie* case that subsection 21(a) of LA FOIP applies to the following Records: 200 (RMR0425), 364 (RMR0487), 187 (RMR0854), 551 (RMR0833), 583 (RMR0660), 588 (RMR0665), 664 (RMR0164) and 925 (RMR0757).

[131] I find that the RM did establish that a *prima facie* case that subsection 21(a) of LA FOIP applies to the remaining records that were withheld in full with the exceptions set out in paragraphs [129] and [130].

- [132] I find that the RM did not properly apply subsection 21(a) of LA FOIP to portions of the following Records: 39 (RMR0031), 915 (RMR0039), 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), 774 (RMR0025), 539 (RMR0820), and 540 (RMR0821) - email from the RM's administrator to the Applicant sent on May 4, 2020 at 10:07:01 am and the Applicant's response sent on May 4, 2020 at 11:54 am.
- [133] I find that the RM properly applied subsection 21(a) of LA FOIP to the remaining portions of Record 540 (RMR0821) with the exception set out in paragraph [132].
- [134] I find that the RM did not properly apply subsection 21(a) of LA FOIP to the headers, footers, subject lines and confidentiality statements in the records withheld in part.
- [135] I find that the RM did not properly apply subsection 21(b) of LA FOIP to Records 200 (RMR0425), 364 (RMR0487), 187 (RMR0854), 551 (RMR0833), 583 (RMR0660), 588 (RMR0665), 664 (RMR0164), 925 (RMR0757) and 540 (RMR0821) – email from the Applicant to the RM on page 2.
- [136] I find that the RM did not properly apply subsection 21(b) of LA FOIP to the headers, footers, subject lines and confidentiality statements in the records.
- [137] I find that the RM properly applied subsection 21(b) of LA FOIP to Records 39 (RMR0031), 43 (RMR0039), 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), 774 (RMR0025), 915 (RMR0039) and Record 540 (RMR0821) with the exception of the email from the RM's administrator to the applicant sent on May 4, 2020 at 10:07:01.
- [138] I find that the information withheld from Record 526 (RMR0082) qualifies as personal information pursuant to subsection 23(1) of LA FOIP.
- [139] I find that the RM properly applied subsection 28(1) of LA FOIP to Record 526 (RMR0082).

V RECOMMENDATIONS

- [140] I recommend that the RM release to the Applicant, within 30 days of issuance of this Report, Records 351 (RMR0601), 377 (RMR0521), 378 (RMR0121), 386 (RMR0141), 390 (RMR0145), and 391 (RMR0146).
- [141] I recommend that, within 30 days of the issuance of this Report, the RM amend its policies or practices for processing access to information requests to ensure that the requests are processed in accordance with the timelines set out in LA FOIP.
- [142] I recommend that the RM ensure it complies with section 7 of LA FOIP by quoting the applicable subsections in its decisions.
- [143] I recommend that, within 30 days of issuance of this Report, the RM conduct another search for all records requested by the Applicant and issue a new section 7 decision, with a copy to my office, that includes details of its search efforts and its decision on any additional responsive records found during the search.
- [144] I recommend that, within 30 days of issuance of this Report, the RM consider releasing the non-responsive records listed in the Appendix, subject to any exemptions that may apply.
- [145] I recommend that, within 30 days of issuance of this Report, the RM release the following Records or portions of Records to the Applicant: 200 (RMR0425), 364 (RMR0487), 187 (RMR0854), 551 (RMR0833), 583 (RMR0660), 588 (RMR0665), 664 (RMR0164), 925 (RMR0757), 915 (RMR0039), 536 (RMR0817), 537 (RMR0818), 539 (RMR0820), and 540 (RMR0821) - email from the RM's administrator to the Applicant sent on May 4, 2020 at 10:07:01 am and the Applicant's response sent on May 4, 2020 at 11:54 am.
- [146] I recommend that, within 30 days of the issuance of this Report, the RM release to the Applicant the headers, footers, subject lines and confidentiality statements in the records listed in the Appendix with the exception of the emails that were previously released to the Applicant in full.

[147] I recommend that the RM continue to withhold the records or portions of records other than the records or portions of records identified in paragraphs [140], [144], [145], and [146] above.
