

REVIEW REPORT 293-2023

Regina Police Service

March 11, 2024

Summary:

The Applicant submitted an access to information request to the Regina Police Service (RPS) for any and all records in their name. The Applicant also indicated they would like to see what officers see when their name is brought up on the computer. In response, the RPS provided the Applicant access to some of the records requested but withheld others, in part and in full, pursuant to subsections 13(1)(b), 14(1)(a), (c), (g), (j), (k), and 28(1) of The Local Authority Freedom of Information and Protection of Privacy Act (LA FOIP). The Applicant requested a review by the Commissioner. In the course of the review, RPS released to the Applicant some of the records it had initially withheld pursuant to subsections 14(1)(a) and (g) of LA FOIP. However, RPS applied additional discretionary exemptions (subsections 14(1)(i) and (k.2) of LA FOIP) as reasons for withholding records from the Applicant. The Commissioner did not consider the discretionary exemptions raised by the RPS pursuant to his office's Rules of Procedure. The Commissioner summarized his findings and recommendations in the Appendix to this Report. He recommended that the RPS follow the recommendations set out in the Appendix.

I BACKGROUND

[1] On April 13, 2023, the Regina Police Service (RPS) received the following access to information request under *The Local Authority Freedom of Information and Protection of Privacy Act* (LA FOIP) from the Applicant:

Any and all records you have in my name. And I would like to see what the officers see when my name is brought up in [sic] the computer.

- [2] On June 12, 2023, RPS responded to the Applicant's access request. RPS cited subsections 13(1)(b), 14(1)(c), and 28(1) of LA FOIP as its reasons for withholding 86 pages of records in full. It also said it was withholding, in its entirety, two case files in full, pursuant to 14(1)(a) and (g) of LA FOIP. However, it was providing partial access to the remainder of the records. It cited subsections 14(1)(c), (j), (k), and 28(1) of LA FOIP as its reason for withholding portions of the remaining pages of records.
- [3] On November 6, 2023, the Applicant requested a review by my office.
- [4] On December 8, 2023, my office notified the RPS and the Applicant that my office would be undertaking a review.
- [5] On February 22, 2024, in the course of my office's review, RPS provided records to the Applicant that it previously withheld pursuant to subsections 14(1)(a) and (g) of LA FOIP. However, RPS applied new discretionary exemptions (subsection 14(1)(i) and (k.2) of LA FOIP) that it did not cite in its decision letter of June 12, 2023, to the Applicant.
- [6] On February 26, 2024, the RPS provided its submission to my office. The Applicant did not provide a submission.

II RECORDS AT ISSUE

- [7] At issue is 330 pages of records, as described in the Appendix. RPS provided my office with two sets of records, the "Original Copy" and the "Working Copy." The Original Copy contains 330 pages of records at issue. The Working Copy contains 174 pages of records, which were provided to the Applicant, with portions of the pages redacted. For the remaining pages of records that were withheld in full, RPS divided the records into various colour-coded folders for my office's review.
- [8] As described in the background of this Report, RPS identified two additional discretionary exemptions, subsections 14(1)(i) and (k.2) of LA FOIP, as reasons for withholding portions of records. RPS had not identified these discretionary exemptions in its decision letter dated

June 12, 2023 to the Applicant (RPS' response to the Applicant pursuant to section 7 of LA FOIP). Pursuant to section 2-4(3) of my office's *Rules of Procedure*, my office does not consider discretionary exemptions not included in a local authority's section 7 response unless there are exceptional circumstances. There are no exceptional circumstances in this case. Therefore, I will not be considering subsections 14(1)(i) or (k.2) of LA FOIP in this review.

III DISCUSSION OF THE ISSUES

1. Do I have jurisdiction?

[9] RPS qualifies as a "local authority" pursuant to subsection 2(1)(f)(viii.1) of LA FOIP. Therefore, I find that I have jurisdiction to conduct this review.

2. Did RPS properly apply subsection 28(1) of LA FOIP?

- [1] RPS applied subsection 28(1) of LA FOIP to pages 6, 7, 9 to 14, 16, 18, 24, 27 to 29, 39, 45 to 49, 56, 62, 64 to 68, 74, 75, 83, 87 to 95, 100, 102 to 104, 109 to 111, 113, 115 to 118, 120 to 127, 129 to 135, 138, 139, 142, 143, 147, 148, 151, 156, 157, 159 to 162, 164, 166, 220 to 256, and 292 to 330 of the Original Copy.
- [2] Subsection 28(1) of LA FOIP provides:
 - **28**(1) No local authority shall disclose personal information in its possession or under its control without the consent, given in the prescribed manner, of the individual to whom the information relates except in accordance with this section or section 29.
- [3] In order for subsection 28(1) of LA FOIP to apply, the withheld information must qualify as a third party individual's "personal information" as defined by subsection 23(1) of LA FOIP. Relevant to this review are the following subsections of 23(1) of LA FOIP:
 - **23**(1) Subject to subsections (1.1) and (2), "personal information" means personal information about an identifiable individual that is recorded in any form, and includes:

- (a) information that relates to the race, creed, religion, colour, sex, sexual orientation, family status or marital status, disability, age, nationality, ancestry or place of origin of the individual;
- (b) information that relates to the education or the criminal or employment history of the individual or information relating to financial transactions in which the individual has been involved;
- (c) information that relates to health care that has been received by the individual or to the health history of the individual;
- (d) any identifying number, symbol or other particular assigned to the individual;
- (e) the home or business address, home or business telephone number, fingerprints or blood type of the individual;
- (f) the personal opinions or views of the individual except where they are about another individual;
- (h) the views or opinions of another individual with respect to the individual;
- (k) the name of the individual where:
 - (i) it appears with other personal information that relates to the individual; or
 - (ii) the disclosure of the name itself would reveal personal information about the individual.
- [4] In its submission, RPS indicated it applied subsection 28(1) of LA FOIP to information about other individuals that were not the Applicant.
- [5] Based on a review, RPS applied subsection 28(1) of FOIP to the names of third party individuals and information about them. The types of information redacted are the names of third parties, their addresses, dates of birth, information about their health status, information in occurrent reports and officer's notes about incidents involving third party individuals. Such information qualifies as personal information as defined by subsections 23(1)(a), (b), (c), (d), (e), (f), (h), and (k) of LA FOIP. I find that RPS properly applied subsection 28(1) of LA FOIP to some of the records at issue. See the Appendix for my findings and recommendations.

- [6] However, I note that RPS also applied subsection 28(1) of FOIP to information about the Applicant. For example, at paragraph 4 of page 75 of the Original Copy (also page 75 of the Working Copy), RPS withheld information about the Applicant that a third party individual said about the Applicant. What was said about the Applicant is the Applicant's personal information, not the third party's personal information, pursuant to subsection 24(1)(h) of LA FOIP. Another example is at paragraphs 6 and 7 of page 88 of the Original Copy (page 81 of the Working Copy), where a third party provided information about the Applicant. The information is about the Applicant, and so it is the Applicant's personal information, not the third party's. Therefore, I find that RPS improperly applied subsection 28(1) of LA FOIP to some of the pages where the information is the Applicant's personal information. I recommend that RPS redact the information pursuant to section 8 of LA FOIP. That is, sever the records in such a way that as much of the Applicant's personal information is released while withholding information about third parties pursuant to subsection 28(1) of LA FOIP. My findings and recommendations are in the Appendix.
- [7] Furthermore, I note that RPS applied subsection 28(1) of LA FOIP to information that, by withholding the information, is an absurd result. In past reports (for example, Review Report 148-2023 at paragraph [38]), an "absurd result" is to withhold information that:
 - Is within a person's knowledge because they provided it;
 - Was provided when the individual was present; and/or
 - Is clearly within the person's knowledge.
- [8] An example of where RPS has applied subsection 28(1) of LA FOIP, but is an absurd result, is at pages 9 to 11 of the Original Copy (also pages 10, 12, and 13 of the Working Copy). RPS applied subsection 28(1) of LA FOIP to withhold information about a third party. However, based on a review of the remainder of the information on pages 9 to 11 of the Original Copy, the information is clearly within the Applicant's knowledge since the Applicant was present when information about the third party was collected. Based on the content of the record, it appears the Applicant is aware of and knows the third party individual.

- [9] Another example of an absurd result is where RPS applied subsection 28(1) of LA FOIP to paragraphs 5 and 6 of page 47 of the Original Copy (page 48 of the Working Copy 2). The withheld information was provided by the Applicant to the RPS. Therefore, it would be an absurd result to withhold such information pursuant to subsection 28(1) of LA FOIP.
- [10] Another example of an absurd result is where RPS applied subsection 28(1) of LA FOIP to the victim impact statements at pages 318 to 330 of the Original Copy ("RA22076432 VIS Statement 1" and "RA22076432 VIS Statement 2" of the Pink Folder in the "Previous Open Curt Case Withheld" folder). The victim impact statements include information on them that says the statements are public documents and are provided to the person charged with the crime. It says:
 - Your completed Victim Impact Statement will be given to the person charged with the crime and his/her lawyer. This is called disclosure and is required by law.
- [11] The Applicant was the person charged with a crime, and so the Applicant already has received a copy of the victim impact statements. Therefore, it is an absurd result to withhold them from the Applicant.
- [12] In summary, I find it is an absurd result to withhold the information in the record as outlined at paragraphs [8] to [11] of this Report, and that RPS did not properly apply subsection 28(1) of LA FOIP to this information. My findings and recommendations are set out in the Appendix.
- [13] Additionally, RPS applied subsection 28(1) of FOIP in a blanket fashion to pages 220 to 256 of the Original Copy (the Purple Folder). However, the Applicant's personal information appears on certain pages, such as pages 231 to 237 of the Original Copy ("RA13009357 Statement 3" and "RA13009357 Statement 4" of the Purple Folder). I find that RPS improperly applied subsection 28(1) of LA FOIP the Applicant's own personal information. My findings and recommendations are set out in the Appendix.

- [14] Also, pages 292 to 294 of the Original Copy (the first three pages of the Pink Folder in the "Previous Open Court Case Withheld" Folder) are court documents, which are a matter of public record. Subsection 3(1)(b) of LA FOIP provides that LA FOIP does not apply to material that is a matter of public record. I find that RPS improperly applied subsection 28(1) of LA FOIP to pages 292 to 294 of the Original Copy (the first three pages of the Pink Folder in the "Previous Open Court Case Withheld" Folder). My findings and recommendations are set out in the Appendix.
- [15] Finally, RPS included a number of pages of records that do not appear to involve the Applicant on pages 253 to 256 and 257 to 307 of the Original Copy. I have listed the corresponding files from the colour-coded folders sent to us by the RPS below:
 - "RA16054268 Statement 2", "RA16054268 Supp 1", "RA16054268 Supp 2", "RA16054268 Supp 3" of the Purple Folder;
 - the Red Folder within the "Previous Open Court Case Withheld" folder;
 - the Green Folder in the "Previous Open Court Case Withheld" folder; and
 - the "RM20047453 Court Order", "RM20047453 Drug Property Report", "RM20047453 Notice of forfeiture", "RM20047453 Notice of Intention", "RM20047453 Photo Log", "RM20047453 Report to a Justice 1", "RM20047453 Report to a Justice 2"; and "RM20047453 Report to a Justice 3" of the Pink Folder within the "Previous Open Court Case Withheld" folder.
- [16] The above-described records appear to be about matters involving third party individuals and not the Applicant. However, RPS applied subsection 28(1) of LA FOIP to these records in a blanket fashion. Section 8 of LA FOIP requires local authorities such as the RPS to conduct a line-by-line analysis of a record. The local authority is to sever the portions of the record that may qualify for a mandatory or discretionary exemption and release the balance of the record to the Applicant (see Review Report 156-2017 & 264-2017 at [19]). Subsection 28(1) of LA FOIP applies to personal information of third parties. But it does not apply to other information such as headers and footers of the records at issue that do not contain personal information of third parties. I find that RPS properly applied subsection 28(1) of FOIP to the personal information of third parties on pages 253 to 307 of the Original Copy. However, I find that RPS improperly applied subsection 28(1) of LA

FOIP to the non-personal information that appears on these pages of the Original Copy. My recommendations and findings are in the Appendix.

3. Did RPS properly apply subsection 14(1)(c) of LA FOIP?

- [17] RPS applied subsection 14(1)(c) of LA FOIP to pages 28 to 35, 37 to 39, 187 to 219 and 257 of the Original Copy.
- [18] Subsection 14(1)(c) of LA FOIP provides:
 - 14(1) A head may refuse to give access to a record, the release of which could:
 - (c) interfere with a lawful investigation or disclose information with respect to a lawful investigation;
- [19] My office uses the following two-part test to determine if subsection 14(1)(c) of LA FOIP applies:
 - 1. Does the local authority's activity qualify as a "lawful investigation?"
 - 2. Does one of the following exist?
 - a) Could release of the information interfere with a lawful investigation?
 - b) Could release disclose information with respect to a lawful investigation?

(Guide to LA FOIP, Chapter 4, "Exemptions from the Right of Access," updated October 18, 2023 [Guide to LA FOIP, Ch. 4] at pp. 54-56)

[20] Below is an analysis to determine if the two-part test is met.

1. Does the local authority's activity qualify as a "lawful investigation"?

[21] A "lawful investigation" is an investigation that is authorized or required and permitted by law. The local authority should identify the legislation under which the investigation is occurring. The investigation can be concluded, active and ongoing or be occurring in the future (*Guide to LA FOIP*, Ch. 4, p. 54).

[22] In its submission, RPS indicated it was conducting a lawful investigation under the *Controlled Drugs and Substances Act* (CDSA). Based on a review of the records, including portions that were released to the Applicant, my office noted that the RPS' activities were indeed a lawful investigation under the CDSA, including the obtaining and executing search warrants under the CDSA. I find that the RPS' activity qualifies as a lawful investigation.

2. Does one of the following exist?

- a) Could release of the information interfere with a lawful investigation?
- b) Could release disclose information with respect to a lawful investigation?
- [23] Section 14 of LA FOIP uses the word "could" versus "could reasonably be expected to" as seen in other provisions of LA FOIP. The threshold for could is somewhat lower than a reasonable expectation. The requirement for could is simply that the release of the information could have the specified result. There would still have to be a basis for asserting the harm could occur. If it is fanciful or exceedingly remote, the exemption should not be invoked (*Guide to LA FOIP*, Ch. 4, p. 54).
- [24] RPS did not provide arguments for this particular part of the test. However, on the face of the records, I find that the information on pages 28 to 35, 37 to 39, 187 to 219 and 257 of the Original Copy (the Red Folder and the other "Red Folder" within the "Previous Open Court Case Withheld" folder) would disclose information with respect to a lawful investigation.
- [25] Based on the above, both parts of the test are met. I find that RPS properly applied subsection 14(1)(c) of LA FOIP to pages 28 to 35, 37 to 39, 187 to 219 and 257 of the Original Copy (the Red Folder and the other "Red Folder" within the "Previous Open Court Case Withheld" folder). My findings and recommendations are in the Appendix.

4. Did RPS properly apply subsection 14(1)(k) of LA FOIP?

- [26] RPS applied subsection 14(1)(k) of LA FOIP to pages 27, 68, 115 to 117, 125 to 127, 129 to 133, and 138 of the Original Copy.
- [27] Subsection 14(1)(k) of LA FOIP provides:
 - 14(1) A head may refuse to give access to a record, the release of which could:
 - (k) interfere with a law enforcement matter or disclose information respecting a law enforcement matter;
- [28] My office uses the follow two-part test to determine if subsection 14(1)(k) of LA FOIP applies:
 - 1. Is there a law enforcement matter involved?
 - 2. Does one of the following exist?
 - a) Could release of information interfere with a law enforcement matter?
 - b) Could release disclose information with respect to a law enforcement matter?

(*Guide to LA FOIP*, Ch. 4, pp. 78-80)

[29] Below is an analysis to determine if the two-part test is met.

1. Is there a law enforcement matter involved?

"Law enforcement" includes policing and criminal intelligence. Policing refers to the activities of police services. This means activities carried out under the authority of a statute regarding the maintenance of public order, detection and prevention of crime or the enforcement of law. Criminal intelligence is information relating to a person or group of persons compiled by law enforcement to anticipate, prevent or monitor possible criminal activity. Intelligence-gathering is sometimes a separate activity from the conduct of specific investigations. Intelligence may be used for future investigations, for activities aimed at preventing the commission of an offence, or to ensure the security of individuals or organizations (*Guide to LA FOIP*, Ch. 4, p. 75).

- "Law enforcement" also includes investigations, inspections or proceedings conducted under the authority of or for the purpose of enforcing an enactment which led to or could lead to a penalty or sanction being imposed under the enactment. Investigation has been defined, in general, as a systematic process of examination, inquiry and observations. Inspection has been defined, in general, as a careful examination. Legal proceeding has been defined, in general, as any proceeding authorized by law and instituted in a court or tribunal to acquire a right or to enforce a remedy (*Guide to LA FOIP*, Ch. 4, p. 75).
- [32] In its submission, RPS indicated that the records were regarding an investigation under the CDSA. RPS indicated there was an offence pursuant to subsection 7(2)(a.1) of the CDSA and that charges were laid. Based on a review of the records, except for page 68 of the Original Copy (page 69 of the Working Copy), the law being enforced is the CDSA. The first part of the two-part test is met. I will consider the second part of the two-part test.
- [33] Regarding page 68 of the Original Copy (page 69 of the Working Copy), RPS did not provide arguments as to how the matter is a law enforcement matter. Based on a review of these pages, I cannot determine there is a law enforcement matter involved. The first part of the two-part test is not met for page 68 of the Original Copy (page 69 of the Working Copy). I find that RPS did not properly apply subsection 14(1)(k) of LA FOIP to page 68 of the Original Copy (page 69 of the Working Copy). See Appendix for my findings and recommendations.

2. Does one of the following exist?

- a) Could release of information interfere with a law enforcement matter?
- b) Could release disclose information with respect to a law enforcement matter?
- [34] RPS did not provide any specific information in its submission regarding this particular part of the test. However, based on a review of the records, I find that the release of the records would disclose information with respect to the law enforcement matter. The second part of the test is met. I find that RPS properly applied subsection 14(1)(k) of LA FOIP to

pages 27, 115 to 117, 125 to 127, 129 to 133 and 138 of the Original Copy (pages 28, 116 to 118, 119 to 121, 122, 126, and 131 of the Working Copy).

5. Did RPS properly apply subsection 14(1)(j) of LA FOIP?

- [35] RPS applied subsection 14(1)(j) of LA FOIP to pages 100, 108, 125, 126, 133 and 147 of the Original Copy. I have already found that RPS properly applied subsections 28(1), 14(1)(c) or (k) of LA FOIP to the portions on which RPS applied subsection 14(1)(j) of LA FOIP. Therefore, I only need to consider subsection 14(1)(j) of LA FOIP on pages 100, 108 and 147 of the Original Copy.
- [36] Subsection 14(1)(j) of LA FOIP provides:
 - 14(1) A head may refuse to give access to a record, the release of which could:
 - (j) facilitate the commission of an offence or tend to impede the detection of an offence;
- [37] My office uses the following two-part test to determine if subsection 14(1)(j) of LA FOIP applies. However, only one of the questions needs to be answered in the affirmative for the exemption to apply.
 - 1. Could the release of the record facilitate the commission of an offence?
 - 2. Could the release of the record tend to impede the detection of an offence? (*Guide to LA FOIP*, Ch. 3, pp. 75-76)
- [38] Below is an analysis to determine if one or both parts of the two-part test is met:
 - 1. Could the release of the record facilitate the commission of an offence?
- [39] Earlier, I discussed the difference between the phrases "could" and "could reasonably be expected to."
- [40] Page 76 of Guide to LA FOIP at Ch. 4, provides the following definitions:

- "Facilitate" means to make the occurrence of something easier; to render less difficult.
- "Commission" in this context means the action of committing an offence.
- "Offence" means a violation of the law; a crime.
- [41] RPS provided the following list of reasons why it applied subsection 14(1)(j) of LA FOIP (as quoted from its submission):
 - i. 900 Codes are Regina Police Service Complaint Codes and are used to provide quality service and ensure the best utilization of our resources.
 - ii. It is the view of RPS that if the public became aware of our 900 codes the knowledge of them could be used to impede an offence by diverting calls for service.
 - iii. RPS has utilized encryption for our radio transmissions, in order to protect these 900 codes from being diverted and used to impede an offence.
 - iv. Exemptions applied as per IPC report 353-2019 and 132-2022.
- In past reports, I have found that "ten codes" are law enforcement intelligence information, and that disclosing them could facilitate the commission of an offence, which would reveal law enforcement intelligence (see Review Reports 037-2018, 023-2019, 098-2019, 353-2019, and 077-2023). Similarly, I find that RPS properly applied subsection 14(1)(j) of LA FOIP to the 900 codes on pages 100, 108 and 147 of the Original Copy (page 106, 110, and 171 of the Working Copy). See the Appendix for my findings and recommendations.
- 6. Did RPS properly apply subsection 13(1)(b) of LA FOIP?
- [43] RPS applied subsection 13(1)(b) of LA FOIP to pages 171 to 186 of the Original Copy.
- [44] Subsection 13(1)(b) of LA FOIP provides:
 - **13**(1) A head shall refuse to give access to information contained in a record that was obtained in confidence, implicitly or explicitly, from:

• • •

- (b) the Government of Saskatchewan or a government institution;
- [45] My office uses the follow three-part test to determine if subsection 13(1)(b) of LA FOIP applies:
 - 1. Was the information obtained from the Government of Saskatchewan?
 - 2. Was the information obtained implicitly or explicitly in confidence?
 - 3. Is there consent to disclose the information or has the information been made public?
- [46] Below is an analysis to determine if subsection 13(1)(b) of LA FOIP applies.
 - 1. Was the information obtained from the Government of Saskatchewan or its agencies, Crown corporations or other institutions?
- [47] Page 22 of Guide to LA FOIP at Ch. 4, provides the following definitions:
 - "Obtained" means to acquire in any way; to get possession of; to procure; or to get a hold of by effort.
 - "Information" means facts or knowledge provided or learned as a result of research or study.
- [48] The records to which RPS applied subsection 13(1)(b) of LA FOIP are records from the Regina Qu'Appelle Health Region (now part of the Saskatchewan Health Authority (SHA)). In its submission, RPS said:

The Regina General Hospital is considered a "trustee" under *The Health Information Protection Act* and also meets the criteria for government institution and or regional health authority or health care organization, which is identified under section 13(1)(b) of *The Local Authority Freedom of Information and Protection of Privacy Act*

[49] The Regina General Hospital is a part of the SHA. The SHA is not the Government of Saskatchewan or its agencies, Crown Corporations or other institutions. The first part of the three-part test is not met. There is no need to consider the two other parts of the test. I find that RPS did not properly apply subsection 13(1)(b) of LA FOIP to pages 171 to 186

of the Original Copy (the Blue Folder). See the Appendix for my findings and recommendations.

- [50] Confusingly, RPS also indicated that pages 171 to 186 of the Original Copy are information about a third party individual and not the Applicant, but only applied subsection 13(1)(b) of LA FOIP as its reason for refusing access to these pages. Based on a review of these pages, my office noted that the records are indeed personal information of a third party individual. I find that subsection 28(1) of LA FOIP would apply to pages 171 to 186 of the Original Copy (Blue Folder). I recommend that RPS withhold pages 171 to 186 of the Original Copy (Blue Folder), in their entirety, pursuant to subsection 28(1) of LA FOIP. See the Appendix.
- [51] Earlier, I noted that RPS applied two discretionary exemptions (subsections 14(1)(i) and (k.2) of LA FOIP) that it did not cite in its letter dated June 12, 2023, to the Applicant, which was the section 7 decision to the Applicant. My office's procedure is not to consider discretionary exemptions that are not raised in the section 7 decision to the Applicant unless there are exceptional circumstances. This case is no exception. Therefore, I will not be considering subsections 14(1)(i) and (k.2) of LA FOIP where RPS applied these exemptions. This includes where RPS applied subsection 14(1)(i) of LA FOIP on pages 114 and 258 to 291 of the Original Copy (page 115 of the Working Copy and the "Green Folder" within the "Previous Open Court Case Withheld" folder) and where it applied subsection 14(1)(k.2) on page 115 of the Original Copy (page 116 of the Working Copy). I recommend that RPS redact the personal information of third party individuals from pages 114 to 115 and 258 to 291 of the Original Copy pursuant to subsection 28(1) of LA FOIP and release the remainder to the Applicant. See the Appendix.

IV FINDINGS

- [52] I find that I have jurisdiction to conduct this review.
- [53] I find that RPS properly applied subsection 28(1) of LA FOIP to some of the records at issue.

- [54] I find that RPS improperly applied subsection 28(1) of LA FOIP to some of the pages where the information is the Applicant's personal information.
- [55] I find that RPS improperly applied subsection 28(1) of FOIP that would produce an absurd result in some cases.
- [56] I find that RPS improperly applied subsection 28(1) of FOIP the Applicant's own personal information.
- [57] I find that RPS properly applied subsection 28(1) of FOIP to the personal information of third parties.
- [58] I find that RPS improperly applied subsection 28(1) of LA FOIP to the non-personal information that appears on pages 253 to 307 of the Original Copy.
- [59] I find that RPS properly applied subsection 14(1)(c) of LA FOIP to pages 28 to 35, 37 to 39, 187 to 219 and 257 of the Original Copy (the "Red Folder" and the other "Red Folder" within the "Previous Open Court Case Withheld" folder).
- [60] I find that RPS properly applied subsection 14(1)(k) of LA FOIP to pages 27, 115 to 117, 125 to 127, 129 to 133, and 138 of the Original Copy (pages 28, 116 to 118, 119 to 121, 122, 126, and 131 of the Working Copy).
- [61] I find that RPS properly applied subsection 14(1)(j) of LA FOIP to pages 100, 108 and 147 of the Original Copy (page 106, 110, and 171 of the Working Copy).
- [62] I find that RPS did not properly apply subsection 13(1)(b) of LA FOIP to pages 171 to 186 of the Original Copy (the Blue Folder).
- [63] I find that subsection 28(1) of LA FOIP would apply to pages 171 to 186 of the Original Copy (Blue Folder).

V RECOMMENDATIONS

- [64] I recommend that RPS withhold pages 171 to 186 of the Original Copy ("Blue Folder"), in their entirety, pursuant to subsection 28(1) of LA FOIP.
- [65] I recommend that RPS redact the personal information of third party individuals from pages 114 to 115 and 258 to 291 of the Original Copy pursuant to subsection 28(1) of LA FOIP and release the remainder to the Applicant.
- [66] I recommend that RPS comply with the recommendations in the Appendix.
